The records of this office show that one William Lewis served in the Revolutionary War as a captain in the 1st Virginia Regiment, commanded successively by Colonel Isaac Read, Lt. Col. Green, Col. James Hendricks, and Col. Richard Parker. He received a provisional commission October 2, 1774; was commissioned 1st lieutenant Jan. 27, 1776, and captain September 4, 1776, and his name last appears on the muster roll of the company, dated May 7, 1779, with remark: "On com'd. Virge." (Detached service)

The records also show that one William Lewis served in said war as a major in the 10th Virginia Regiment. His name appears on the records of that organization with remarks: "Commissioned May 12, 1779; transferred to 3d Virginia Regiment; "Deranged (rendered supernumerary) January 1, 1783, but Prisoner till 1st May, 1783."

It is also shown by the records that one Henry Tatum served in that war as an ensign and 2d lieutenant in Captain Gross Scruggs's Company, 5th Virginia Regiment, commanded by Col.

Josiah Parker. His name first appears on pay roll covering the pe-

ried from September 28 to October 28, 1776, as ensign; he was appointed 2d lieutenant December 13, 1776, and he is shown to have been rendered supernumerary September 29, 1778.

Nothing further relative to these men has been found of record, nor has the name Daniel Claiborne nor the name Thomas Claiborne been found on the rolls of any organization of Virginia or Continental troops in service during the War of the Revolution.

The collection of Revolutionary War records in this office is far from complete, and it is suggested as a possibility that additional information can be obtained from the Librarian, Virginia State Library, Richmond, or from the Commissioner of Pensions, Washington, D.C.
